The Court will hold a hearing to determine whether a guardian should be appointed for **Respondent**. The purpose of this proceeding is to protect **Respondent**.

At the hearing, the Court will determine whether **Respondent** is an incapacitated person under CSKT law. If the Court finds that **Respondent** is incapacitated, the Court at the hearing shall also consider whether the proposed guardians should be appointed as guardian of **Respondent**.

The Court may, in its discretion, appoint some other qualified person as guardian. The Court may also, in its discretion, limit the powers and duties of the guardian to allow **Respondent** to retain control over certain activities.

Respondent shall attend the hearing and be represented by an attorney. The petition may be heard and determined in the absence of **Respondent** if the Court determines that the presence of **Respondent** is not possible. If **Respondent** is not represented by an attorney, the Court must appoint an attorney to represent him/her.

The Court may, on its own motion or on request of any interested person, postpone the hearing to another date and time.
